A BILL

To require the Secretary of Health and Human Services to carry out activities to address the public health effects of climate change, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Climate Health Emer-
- 5 gency Act".
- 6 SEC. 2. ISSUANCE OF A CALL TO ACTION.
- 7 (a) In General.—The Secretary of Health and
- 8 Human Services (referred to in this Act as the "Sec-
- 9 retary"), acting through the Surgeon General, shall issue
- 10 a national call to action relating to the health threats and

1	concerns posed by climate change and the health benefits
2	that may be achieved through coordinated action to reduce
3	climate change.
4	(b) RESOURCES FOR HARDEST HIT COMMUNITIES.—
5	In carrying out the activities described in subsection (a),
6	the Secretary, acting through the Surgeon General, shall
7	ensure that information and resources related to the
8	health threats and concerns posed by climate change are
9	reaching the communities most impacted by and most vul-
10	nerable to such health threats and concerns.
11	(c) Coordination for Activities.—To carry out
12	the activities described in subsections (a) and (b), the Sec-
13	retary shall coordinate with—
14	(1) the National Institutes of Health, including
15	the National Institute of Mental Health;
16	(2) the Centers for Disease Control and Preven-
17	tion;
18	(3) the Office of Minority Health;
19	(4) the Substance Abuse and Mental Health
20	Services Administration; and
21	(5) any other agency as determined necessary
22	by the Secretary.
23	(d) Grant Program.—
24	(1) IN GENERAL.—The Secretary shall award
25	grants to State, local, Tribal, and territorial govern-

1	ments and community-based organizations to hire
2	community health leaders to assist in ensuring that
3	resources related to addressing health threats and
4	concerns are reaching the communities described in
5	subsection (b).
6	(2) APPLICATION.—To be eligible to receive a
7	grant under paragraph (1), a State, local, Tribal, or
8	territorial government or nongovernmental commu-
9	nity-based organization shall submit to the Secretary
10	an application at such time, in such manner, and
11	containing such information as the Secretary may
12	require.
13	(3) Priority.—In awarding grants under para-
14	graph (1), the Secretary shall prioritize applications
15	from nongovernmental community-based organiza-
16	tions.
17	(e) Authorization of Appropriations.—There
18	are authorized to be appropriated to carry out this section
19	[for fiscal years].
20	SEC. 3. CLIMATE HEALTH RISK MITIGATION.
21	(a) Grant Program.—
22	(1) In General.—The Secretary, acting
23	through the Director of the Centers for Disease
24	Control and Prevention, shall award grants to State,
25	local, Tribal, and territorial governments and non-

-
governmental community-based organizations for ac-
tivities described under paragraph (4) to mitigate
health threats and concerns posed by climate
change.
(2) Application.—
(A) In general.—To be eligible to receive
a grant under paragraph (1), a State, local,
Tribal, or territorial government or nongovern-
mental community-based organization shall sub-
mit to the Secretary an application at such
time, in such manner, and containing such in-
formation as the Secretary may require includ-
ing an assurance that the grant funds would
supplement and not supplant existing funding.
(B) APPLICATION SUPPORT.—The Sec-
retary shall establish a support program for the
grant application and award process to broaden
the pool of funding applicants and facilitate
participation by qualified but less-resourced ap-
plicants.
(3) Grant Award.—
(A) Priority.—In awarding grants under
paragraph (1), the Secretary shall prioritize ap-

plications that include plans—

7	(B) SEPARATE FEDERAL FUNDING.—In
8	awarding grants under paragraph (1), the Sec-
9	retary may not consider whether the applicant
10	receives other Federal funding.
11	(4) Grant activities.—
12	(A) In general.—The activities described
13	under this paragraph are—
14	(i) hiring staff to plan and carry out
15	strategies to reduce public health threats
16	due to climate change;
17	(ii) programs and capital investments
18	to protect public health from climate
19	change; and
20	(iii) education about the health risks
21	posed by climate change.
22	(B) Enhancement of existing pro-
23	GRAMS.—Activities carried out using grant
24	funds awarded under this section shall enhance,
25	not duplicate or replace, programs or initiatives

1	existing on that date of submission of an appli-
2	cation including existing climate and public
3	health programs and initiatives within the Cen-
4	ters for Disease Control and Prevention such as
5	the Climate and Health Program.
6	(b) CDC Reports.—The Secretary, acting through
7	the Director of the Centers for Disease Control and Pre-
8	vention, shall—
9	(1) conduct an annual study to identify key
10	knowledge gaps related to climate change and public
11	health; and
12	(2) not later than 1 year after the date of en-
13	actment of this Act and annually thereafter, submit
14	a report to Congress, and make available on a pub-
15	licly accessible website, a report on the results of the
16	study conducted under paragraph (1).
17	(c) Training Program.—
18	(1) In general.—The Director of the Centers
19	for Disease Control and Prevention, in coordination
20	with the Director of the National Institutes of
21	Health, shall establish a training program for State
22	local, Tribal, and territorial health professionals in
23	public health and health care related to climate and
24	public health programs and initiatives within the
25	Centers for Disease Control and Prevention such as

1	the Building Resilience Against Climate Effects
2	framework under the Climate-Ready States and Cit-
3	ies Initiative.
4	(2) Enhancement of existing programs.—
5	The training program established under this sub-
6	section shall enhance, not duplicate or replace, pro-

12	(b) Research Priority.—
13	(1) In general.—In carrying out the research
14	program under subsection (a), the Director of the
15	National Institutes of Health shall, subject to para-
16	graph (2), prioritize proposals from researchers—
17	(A) who are partnering with community
18	organizations;
19	(B) whose proposal incorporates com-
20	pensated citizen science and community-based
21	participatory research; or
22	(C) whose proposed project outcomes will
23	serve tangible community needs.
24	(2) Degree of Priority.—In prioritizing pro-

7	a subgroup of individuals including vulnerable and
8	disproportionally impacted populations.
9	"(b) Activities.—
10	"(1) Appointment of coordination offi-
11	CIAL AND CRISIS MANAGERS.—In implementing ac-
12	tivities under a public health crisis declaration under
13	subsection (a), the Secretary shall—
14	"(A) establish and appoint an official in
15	the office of the Secretary to coordinate and
16	plan the emergency response across the Depart-
17	ment and serve as the primary liaison to other
18	relevant Federal agencies; and
19	"(B) establish a crisis manager within
20	each of the relevant operating divisions of the
21	Department including the—
22	"(i) National Institutes of Health, in-
23	cluding the National Institute of Mental
24	Health;

1	"(ii) Centers for Disease Control and
2	Prevention;
3	"(iii) Office of Minority Health;
4	"(iv) Substance Abuse and Mental
5	Health Services Administration; and
6	"(v) any other agency as determined
7	necessary by the Secretary.
8	"(2) Plan for response.—In implementing
9	activities under a public health crisis declaration
10	under subsection (a), the official appointed under
11	paragraph (1)(A), in coordination with the crisis
12	managers established under paragraph (1)(B), shall
13	develop a plan for a response by the Secretary to the
14	public health crisis, including by—
15	"(A) assessing major risks and vulnerable
16	or disproportionately-impacted populations;
17	"(B) identifying existing departmental
18	funding or grant authority available to be uti-
19	lized to address the crisis without compromising
20	efforts to address other public health priorities;
21	"(C) developing a short term strategy to
22	address the crisis including through the use of
23	existing programs; and
24	"(D) developing a long term strategy to
25	address the crisis including an inventory of

1	gaps in Federal, State, local, Tribal, and terri-
2	torial resources and research needed to address
3	the crisis.
4	"(c) Termination.—The public health crisis dec-
5	laration under subsection (a) shall terminate on the earlier
6	of—

12	Secretary.".
